4 - FIRST-AID MEASURES

Routes of exposure

6 - ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel: Do not smoke. Avoid exposure to the product. If necessary, use personal protective equipment as described in Section 8.
